All meals meet Area Agency on Aging Region One, Incorporated (Phoenix, AZ) dietary guidelines for the aging population and are low in salt and sugar to help those following a modified diet. Financially eligible FCC Neighbors have the cost of their meals provided by a grant from the Area Agency on Aging Region One, Incorporated (Phoenix, AZ). Other FCC Neighbors pay for their meals at a price of \$7.25 per meal. During

Wheel Safe: With additional PASS training, certified FCC Volunteers drive or may serve as an assistant in one of the 6 wheelchair accessible vans to safely transport and transfer FCC Neighbors who have special wheelchair accessible transportation needs to and from non-emergency medical appointments. 3. Recreational Van Program: FCC Volunteers drive and accompany Neighbors in groups to shop at grocery stores and local food bank, as well as transport and support them at scheduled social
